<b>Wednesday, June 21, 2017</b>	<b>Governor calls for Special Election. Candidate Filing Begins.</b> First day candidates may file nomination papers with the Secretary of State.
<b>Friday, July 14 – 5 pm</b>	<b>Candidate Filing Deadline.</b> Last day to file nomination papers with the Secretary of State.
<b>Monday, July 24</b>	<b>Worry-Free Postmark Date.</b> Mailed voter registration forms which are postmarked on or before today are considered on time to pre-register for the special election even if they are received after the Pre-Registration deadline of 5 p.m. on July 28.
<b>Friday, July 24 – 5 p.m.</b>	<b>Voter Pre-Registration Deadline</b> The deadline to pre-register to vote for the special election is 5 p.m. This applies to registration in person (including registration at driver's license stations or agencies) or by mail.  <b>Exceptions:</b> Mailed registration forms postmarked on or before Monday, July 24, are considered on time even if they are received after 5 p.m. today.  After today, a person may register to vote at the Auditor's office and vote an absentee ballot using the same process for registering to vote on Election Day, EDR procedures.  <b>Auditor's office must be open until 5 p.m.</b>
<b>Friday, August 4 – 5 p.m.</b>	<b>Last day to request an absentee ballot by mail.</b>  <b>Auditor's office must be open until 5 p.m.</b>
<b>Saturday, August 5 – Election Day</b>	<b>Voters admitted to hospitals or nursing homes</b> after 12 am August 5 may call to request delivery of an absentee ballot. Deadline is 4 p.m. on election day.
<b>Saturday, August 5</b>	<b>County Auditor's Office Open.</b> The county Auditor's Office must be open for at least eight hours for absentee voting and other election business.  <b>Auditor's office must be open 8 a.m. to 5 p.m.</b>

**Last Day for Voters to Fix Incomplete Affidavits.**

Voters have until 5 p.m. to fix incomplete affidavit envelopes.

**Absentee Ballot Postmark Deadline**

Absentee Ballots postmarked by the day before the election and received by the time of the county canvass are considered on time to be counted.

**Absentee Ballot In-Person Deadline.**

Last day to request and vote an absentee ballot in person at the county auditor's office.

**Auditor's office must be open until 5 p.m. if there are incomplete absentee ballots in need of correction.**

**Election Day. Special Election State Representative District 82**

Polls are open from 7 a.m. until 9 p.m. Absentee ballots may be delivered to the county Auditor's Office until 9 p.m.

**Thursday,

**Absentee Ballot Deadline.**

Absentee ballots postmarked on Monday, July 7, or earlier and received before the county canvass are considered to be on time to be counted.

**County Canvass of Votes.**

Board of Supervisors meet to canvass the votes for the special election.

**Recount Request Deadline**

Written requests for a recount must be filed in the auditor's office by 5 p.m. on the third day after the canvass.

**Auditor's office must be open until 5 p.m.**
